Tax Status – NP - Not-for-Profit; P – Proprietary (For Profit)

Patient Days – The total number occupied bed-days for the reporting period.

Dollars Paid per Patient Day - The average dollar amount expected to be collected per adjusted patient day.

Hours per Patient Day - The average number of hours the facility paid to employees or an agency, per adjusted patient day.

Total Margin (%) - A percentage that expresses the difference between total revenue and cost as a proportion of total revenue

Medicaid Participation - Number of Medicaid patient days in relation to total patient days.
